## Background of CJCC

- CJCC established in March 2016 by resolution of the BOCC
- Previous areas of work:
- Stepping Up/CIT/Mobile Response
- Racial and Ethnic Disparities in the Criminal Justice System
- Building Data Capacity
- Diversion/Alternatives to Incarceration/Pretrial Release
- Expanding Services within the DCCF

#### Present

- CJCC Survey, November 2022
- 127 responses, 10 current or past CJCC members
- Themes to consider from Survey
- Considerations for New Goals:
- Select a few goals that we can commit to
- Are actionable and measurable
- Supported by agency executives
- A mix of short, mid, and longer term

## 2023-2024 Work Plan Draft Ideas

### Justice System Focused Ideas

- 1. Institute Regular Jail Review Process
- Ongoing review of population-specific drivers of jail population
- How can we maximize the use of current resources and processes in the absence of BIDS?
- Key Stakeholders: DGSO, Pretrial Services, Municipal and District Court, DA's Office
- 2. Failure to Appear
- Improve Court Appearance Rates
- Alternative Response to FTA
  - May benefit from process mapping for each Court as a first step
- Key Stakeholders: Municipal and District Courts, Self Help Center
- 3. Alternative Responses to Probation Violations
- Better understand processes and responses from the 3 agencies (Municipal Court, Court Services, and Community Corrections)
- Key Stakeholders: Municipal Court, Court Services, Community Corrections, DA's Office, District Court

## Justice System Focused Ideas, Cont.

- 4. Competency Restoration
- Need to better understand these processes and impacts on the justice system
- How can we maximize the use of the jail-based restoration program?
- Circle back to CJCC for next steps after further work by Bob Tryanski and Katy Fitzgerald
- 5. Pretrial Defendants
- Better to consider starting in later summer 2023
- Validate Pretrial Risk Assessment
- Consider Application for Targeted Technical Assistance from APPR

# Additional Ideas Beyond the Justice System

- 6. Align with Existing Community Efforts
- Areas of overlap or shared interest between existing work groups and CJCC-related topics, such as DV, License Restoration, Housing, Community Health Plan
- How can the CJCC meaningfully support these work groups or serve as a conduit for meaningful information sharing?
- 7. Continued Support for Initiatives at Intersection of Behavioral Health and Criminal Justice
- 8. Build out Data Reporting to Monitor Program/Service Outcomes and Promote Transparency
  - Starting with Crisis System Dashboards as an example
  - Identify best practice measures across disciplines
  - Track, report, and discuss outcomes on a more regular basis
- 9. Review Bylaws and Infrastructure of CJCC


Racial and Ethnic Disparities
