- 4. If the court determines that a professional employee needs to assist with responding to a request –A \$60 per hour fee for time may be imposed.

- 7. The official records custodian may waive any or all fees associated with responding to a request if the official custodian determines that only minimal time or effort is required to respond to the request and copies to be produced number five pages or less.
- 8. This order modifies and replaces any Administrative Order in relation to the Kansas Open Records Act requests.

ADMINISTRATIVE ORDER NO. 22-02

Appointed Attorney Fees In Certain Cases

WHEREAS, the appointment of counsel for persons who are unable to afford counsel is an important right for persons charged with criminal conduct as adults or juveniles or those persons facing allegations for involuntary commitment, and;

WHEREAS this district has an approved panel of attorneys willing to accept appointments to provide legal counsel to such persons, and;

NOW, THERERFORE, this Court enters the following Order:

- 1) Effective January 1st, 2022, for any appointment of counsel for any adult non-felony or any juvenile case, including appeals, all approved billable hours will be compensated at the rate of \$100 per hour. Except that for any case appointment prior to September 1, 2021, approved billable hours will be compensated at the previous (\$80/hour) rate.
- 2) The non-felony caps that require the submission of a request to approve exceptional billing are increased from \$1,200 to \$1,500 for non-tried cases and from \$2,000 to \$2,500 for tried cases. For indirect contempt, care & treatment, sentence modification and probation/parole violations, the caps are increased from \$500 to \$625.00. If the appointment pre-dated September 1, 2021, then all hourly rates/caps apply as they did at the time of the appointment.

Order Affecting Assignment of Cases Under Local Court Rule No. 1

WHEREAS, it is the responsibility of the Chief Judge to determine case assignments or reassignments in this district in accordance with our local rules; and

WHEREAS, this district has determined that it best serves the interests of justice, the administration of law and the interests of our community to administer certain specialty courts, which, at the time of this order, includes Behavioral Health Court ("BHC")(presently Division Two) and Drug Court (presently Division Three); and

WHEREAS, this district has likewise determined that cases involving the care and treatment of persons pursuant to K.S.A. 59-2945, et seq. (concerning, the care and treatment of persons with mental illness) and/or K.S.A. 59-29b45, et seq., (concerning the care and treatment of persons with alcohol or other substance abuse problems) are most comprehensively administered and monitored by assigning them to a single division;

NOW, THEREFORE, the clerk is hereby directed that in assigning or reassigning cases pursuant to the directive of Local Court Rule No. 1, the following applies:

- 1) Cases filed pursuant to the care and treatment of persons pursuant to either K.S.A. 59-2945, *et seq.*, or 59-29b45, *et seq.*, ("CT cases") shall be assigned to Division Five, except that when the District Attorney's office provides notice to the clerk at the time of filing that the proposed patient has or had a case (past or present) assigned to BHC, the clerk shall assign the case to Division Two.
 - For any CT case assigned to Division Five, if that division discovers that the person had/has a current or prior BHC case with Division Two, upon the direction of the Division Five judge, the clerk shall reassign the case to Division Two.
- 2) When any defendant is accepted for participation in either BHC or Drug Court, the original division judge (if different from the division administering that specialty court) shall notify the clerk of that acceptance and the clerk shall then reassign the case to the division where the specialty court program is being administered.

If it is determined that the defendant who was accepted is no longer qualified to participate in the program, the division judge administering the program may direct the clerk to reassign the case to the division where it originated or keep the case for resolution.

The Court Clerk shall not be responsible for sending notice to any other interested person or agency. Any such additional notice required pursuant to K.S.A. 21-6614 shall be the responsibility of the party as set forth in the statute.
- c. The Court Clerk shall redirect any petition or proposed order for expungement, or any related filing, to the Division 4 e-flex queue for review and determination.

Any party may request that a hearing on a petition for expungement be heard by another division judge when there exists particular circumstances that the party believes justify such a request. In that event, the request should be directed to the attention of the Division 4 judge for determination.

NOW THEREFORE, for the reasons recited above, it is ordered that the Seventh Judicial District shall be closed on June 20, 2022.

ADMINISTRATIVE ORDER NO. 22-13 Minimum Standard Health Protocols

WHEREAS, this District Court has operated under several local Administrative Orders and transition plans since March 2020 to address the COVID-19 and all variants thereof pandemic ("COVID"). During this same time, the Kansas Supreme Court has also issued Administrative Orders directing operations for the district courts of this State.

WHEREAS, on March 2, 2022, the Kansas Supreme Court issued Administrative Order 2022-PR-014 ("22-PR-14") requiring all district and appellate courts in Kansas to develop and follow their own minimum standard health protocols to avoid exposing court users, staff and judicial officers to COVID.

WHEREAS, this Court has consulted with local health officials, reviewed guidelines from the Kansas Department of Health and Environment, Centers for Disease Control and Prevention and the Occupational Safety and Health Administration concerning the same issues.

NOW, THEREFORE, the following order is entered regarding COVID protocols for this district court:

Voluntary Face Covering and Physical Distancing

All persons should feel free to utilize a face covering or maintain social distance as to them seems most appropriate when entering or conducting business within the Judicial Center. District Court employees should be respectful of such decisions both as to the public and to coworkers. This rule is subordinate to any due process rights that attach to any judicial proceeding within this District.

Particular In-Person Proceedings

Each judge presiding over any hearing retains the right to require such measures as to

them seems appropriate for the safety, security and orderly operation of the proceedings in their

courtroom, to include, without limitation, requiring face coverings for some or all participants

and/or such distancing as they may deem appropriate.

Remote Proceedings

The Court will continue to make active use of remote proceedings. The Court will make

reasonable effort to accommodate any participant in a proceeding who prefers participation by

remote means.

If any previous local administrative order conflicts with the provisions of this Order, this

Order controls.

Order Affecting Assignment of Cases Under Local Court Rule No. 1

WHEREAS, it is the responsibility of the Chief Judge to determine case assignments or reassignments in this district in accordance with our local rules; and

WHEREAS, this district has determined that it best serves the interests of justice, the administration of law and the interests of our community to administer certain specialty courts, which, at the time of this order, includes Behavioral Health Court ("BHC")(presently Division Two) and Drug Court (presently Division Three); and

WHEREAS, this district has likewise determined that cases involving the care and treatment of persons pursuant to K.S.A. 59-2945, *et seq.* (concerning, the care and treatment of persons with mental illness) and/or K.S.A. 59-29b45, *et seq.*, (concerning the care and treatment of persons with alcohol or other substance abuse problems) are most comprehensively administered and monitored by assigning them to a single division; and

WHEREAS, this district has determined that when Protection From Abuse cases pursuant to K.S.A. 60-3101, *et seq.* ("PFA") or Protection from Stalking cases pursuant to K.S.A. 60-31a01, *et seq.*, ("PFS") are filed between parties who have divorce or paternity cases actively pending in this district are most comprehensively administered and monitored by assigning them to the division where the divorce is pending;

NOW, THEREFORE, the clerk is hereby directed that in assigning or reassigning cases pursuant to the directive of Local Court Rule No. 1, the following applies:

- 1) Cases filed pursuant to the care and treatment of persons pursuant to either K.S.A. 59-2945, *et seq.*, or 59-29b45, *et seq.*, ("CT cases") shall be assigned to Division Five, except that when the District Attorney's office provides notice to the clerk at the time of filing that the proposed patient has or had a case (past or present) assigned to BHC, the clerk shall assign the case to Division Two.
 - For any CT case assigned to Division Five, if that division discovers that the person had/has a current or prior BHC case with Division Two, upon the direction of the Division Five judge, the clerk shall reassign the case to Division Two.
- 2) When any defendant is accepted for participation in either BHC or Drug Court, the original division judge (if different from the division administering that specialty court) shall notify the clerk of that acceptance and the clerk shall then reassign the case to the division where the specialty court program is being administered.

If it is determined that the defendant who was accepted is no longer qualified to participate in the program, the division judge administering the program may direct the clerk to reassign the case to the division where it originated or keep the case for resolution.

3) When any petition is filed in a PFA or PFS case, and the parties named in the petition have a pending divorce or paternity case within this District, the duty judge reviewing any such petition may notify the clerk that the case is being reassigned to the Division where the divorce or paternity case is pending and the clerk shall so assign the case without further order or review by the Chief Judge.

Appointed Attorney Fees In Certain Cases

WHEREAS, the appointment of counsel for persons who are unable to afford counsel is an important right for persons charged with criminal conduct as adults or juveniles or those persons facing allegations for involuntary commitment ("Care and Treatment") or other cases requiring appointment where personal liberty is at issue, and;

WHEREAS this Judicial District has approved panels of attorneys willing to accept appointments to provide legal counsel to such persons, and;

WHEREAS, this jurisdiction has historically authorized rates of compensation consistent with the rates authorized by the Legislature of Kansas for felony appointments; and

WHEREAS, the Legislature, effective July 1, 2022, authorized a rate of \$120 per hour for such appointments;

NOW, THERERFORE, this Court enters the following Order:

- 1) Effective immediately, counsel for any adult non-felony (including but not limited to those assigned to Behavioral Health Court or Drug Court and Care and Treatment) or any juvenile case which is compensated at an hourly rate, including appeals, may submit vouchers for billable hours incurred on or after July 1, 2022, at the rate of \$120 per hour.
- 2) The non-felony caps that require the submission of a request to approve exceptional billing are increased from \$1,500 to \$1,800 for non-tried cases and from \$2,500 to \$3,000 for tried cases. For indirect contempt, care & treatment, sentence modification and probation/parole violations, the caps are increased from \$625 to \$750.00.

As an example, if Attorney Joe Smith requests to become attorney of record in 60 cases, that application may occur on a single MSCR form. But, Attorney Joe Smith and Attorney Jill Jones may not submit a single MSCR form for Attorney Joe Smith to become counsel of record in 60 cases and Attorney Jill Jones to become attorney of record in 60 different cases. Two MSCR form requests would need to be submitted.
- 3) Such requests will presumptively be rejected if the total number of cases is less than ten absent special circumstances presented in the request.
- 4) The Chief Judge shall have authority to direct the clerk to reject the MSCR. The Clerk shall also maintain the MSCR in the clerk's record journal.
