WHEREAS, this district has likewise determined that cases involving the care and treatment of persons pursuant to K.S.A. 59-2945, *et seq.* (concerning, the care and treatment of persons with mental illness) and/or K.S.A. 59-29b45, *et seq.*, (concerning the care and treatment of persons with alcohol or other substance abuse problems) are most comprehensively administered and monitored by assigning them to a single division;

NOW, THEREFORE, the clerk is hereby directed that in assigning or reassigning cases pursuant to the directive of Local Court Rule No. 1, the following applies:

 Cases filed pursuant to the care and treatment of persons pursuant to either K.S.A. 59-2945, et seq., or 59-29b45, et seq., ("CT cases") shall be assigned to Division Five, except that when the District Attorney's office provides notice to the clerk at the time of filing that the proposed patient has or had a case (past or present) assigned to BHC, the clerk shall assign the case to Division Two.

For any CT case assigned to Division Five, if that division discovers that the person had/has a current or prior BHC case with Division Two, upon the direction of the Division Five judge, the clerk shall reassign the case to Division Two.

2) When any defendant is accepted for participation in either BHC or Drug Court, the original division judge (if different from the division administering that specialty court) shall notify the clerk of that acceptance and the clerk shall then reassign the case to the division where the specialty court program is being administered.

If it is determined that the defendant who was accepted is no longer qualified to participate in the program, the division judge administering the program may direct the clerk to reassign the case to the division where it originated or keep the case for resolution.

WHEREAS on October 16, 2023, the Kansas Supreme Court issued Administrative Order 2023-CC-074, which directs that documents may be filed with the court clerk by mail, in-person or by fax; and

WHEREAS, this judicial district has the ability to accept delivery of certain documents from practicing attorneys during regular business hours via electronic mail delivery that correlates for all meaningful purposes with the in-person delivery option; and

WHEREAS, making electronic mail delivery available serves the administration of law, increases efficiency of the operations of the district court and assists attorneys in the filing and receipt of necessary court documents;

NOW, THEREFORE, effective immediately, and within the limits of this Order:

- <u>Attorneys only.</u> Any attorney admitted to practice law in this jurisdiction may deliver to the Seventh Judicial District court clerk ("court clerk"), via the email address specified herein, documents for filing in any existing case where said attorney is attorney of record (or the document being submitted is an entry of appearance). Nothing about this Order requires an attorney deliver documents to the court clerk via email. All other options for delivery via fax, in-person or traditional mail remain available.
- Limitations. The following documents are excluded from email delivery and may not be so delivered:
 - a) Petitions, motions or other pleadings which require the payment of a filing fee;
 - b) Documents intended to open or initiate a case (documents must pertain to an already existing case);

- c) Confidential documents or documents that the Court has ordered, or is being requested to order, sealed;
- d) Documents which require court approval or signature before filing. Proposed orders should be sent directly to the judge;
- e) Any document delivered to the court clerk which violates this provision may be struckby the Court without prior notice to the parties and, in that event, will be considered to have NOT been filed in the case regardless of any file stamp applied to the document.
- f) Delivery SHALL BE LIMITED to the <u>public hours of operation</u> for the court clerk presently 8 a.m. to Noon and 1 p.m. to 4:30 p.m. Monday – Friday. Any email delivery outside of these hours will be rejected by the clerk and shall not be effective to constitute delivery for filing within the limitations of this Order.
- <u>Required Information</u>. Emails requesting delivery of documents via the email address authorized by this Order must:
 - a) Include the full case number in the subject line of the email and must include in the body of the email the full caption of the parties to the case;
 - b) Attach documents in PDF format ONLY;
 - c) Attach only documents to be filed in the case identified in the subject line of the email. Thus, an email <u>may</u> contain multiple documents for filing in a single case, but <u>may not</u> include documents for filings in multiple cases in one email.
 - d) Include the following language in the body of the email:"I understand and agree that by using email to file the attached documents, I will have the obligation to provide filed stamped copies to all current counsel of record or to any self-represented litigant in the case, either via electronic mail or U.S. Mail."
- 4) <u>Service of Copies.</u> Any attorney who utilizes the email address authorized by this Order to deliver documents to the court clerk for filing shall be obligated to provide file stamped copies to all then-current counsel of record (or to any self-represented litigant), either via electronic email or U.S. Mail, of any file stamped copies they receive back via email from the court clerk. The attorney receiving the file stamped copy must effectuate the service directed herein within 24 hours of receipt of the file stamped copy from the court clerk.

Upon request of the Court, the attorney must be able to verify that service occurred in accordance with this directive.
