The Committee voted today to send the bylaws update draft to the Full Board for adoption next month. The motion was made by Brad August and seconded by Mindy Andrasevits. Staff Updates – Robert Bieniecki, Jillian Rodrigue

- Personnel:
 - A new intern began with EM this month. She will work on projects through the summer.
 - \circ Jillian Rodrigue will be leaving the staff August 1st. The Deputy Director position has been posted.
- Planning
 - EOP: The EOP draft was submitted to the state with BOCC approval. EM is finalizing updates based on state review feedback.
 - IPPW: Josh is working on a new survey to track progress on identified priorities. The goal is for this program to be as functional as possible.
 - COOP: Plan development with the City of Lecompton is set for this month.
 - Mitigation: The new regional Hazard Mitigation Plan is expected to be up for adoption by September.
- Grants—
 - HMEP: 2024: The Final Planning Meeting for a tabletop exercise by Ascenttra is set for July 15.
 Ascenttra will teach an Incident Action Planning class on August 13, and the tabletop exercise will take place August 14.
 - EMPG: Nothing to report.
- ARPA Project Updates-
 - Sirens, Digipeater Project and Cellular Backup Project: Original project is complete. EM received approval to use further ARPA funds to replace thirty older siren heads. Additional siren work is set to be completed this year paid for out of Capital Improvement Funds.
 - Main EOC: Upgrades were completed last week. The installation of a second amateur radio repeater is being considered as part of this project.
 - o Alternate EOC: Complete.
 - EM Vehicle: Complete.
 - o EM Trailer: Complete.
 - PPE: EM will be purchasing some equipment for other departments and agencies.
 - All ARPA projects will be complete by the end of 2024.
- Volunteers—
 - EOC Support participated in IS-2200 courses last month and will continue training in June.
 - Peer Support will meet again sometime in June.
 - o CERT Volunteers met for an After Action Meeting following the CERT Weekend Class.
 - On May 23rd volunteers attended an advanced Cyber Security class taught by Ben Aldridge.

 - The City of Lawrence has reached out to EM for planning support for July 3rd celebrations and may ask EM Volunteers to work.
