**ADMINISTRATIVE ORDER NO. 15-08
INTERIM ORDER REGARDING ELECTRONIC FILING PROCEDURES**

In an effort to address some issues that have come up since the institution of mandatory e-filing, the court has adopted the following procedures for persons e-filing documents with the clerk of the district court.

1. *Chambers Copies.* Whenever the Local Court Rules require parties to file a chambers copy of a document, the filing party must send a paper copy of the document to the chambers of the judge presiding over the case unless the judge authorizes that party to send a copy by e-mail.
2. *Attorney Vouchers.* Whenever an attorney submits a voucher to the court for payment by the court or BIDS, the voucher should be submitted on paper directly to the judge's chambers. BIDS vouchers, including vouchers for the attorney, experts, and investigators, will be approved by the judge and returned to the attorney for filing with BIDS. Attorneys should submit misdemeanor vouchers in a form which contains a face sheet on which the filing attorney states all pertinent case information and a recapitulation of the fee requested. The supporting data should be attached to the face sheet in a manner such that the face sheet can be removed by the court and scanned into the e-filing system.
3. *Transcript Orders.* When an attorney requests an order for transcript in a case involving an indigent defendant, the attorney should notify the responsible court reporter once the order is signed by the judge.
4. *Certified Copies.* Persons wanting certified copies of e-filed documents should request that the clerk's office provide the desired copies. The clerk's office will e-mail a certified copy to the requesting party. The party may then generate as many copies of the document as they need. If the party requires an original signature on the document he or she should make arrangements for the copy with the person whose signature is required to be on the document.
5. *Attachments to E-filed Documents.* To the extent possible attorneys e-filing motions or memoranda with exhibits attached should file the exhibits as a part of the original document. If the document is too large to file with the exhibits attached, the exhibits should be clearly labeled or titled as attachments to the main document.


SEVENTH JUDICIAL DISTRICT ADMINISTRATIVE ORDER 15-15

As Chief Judge of this Judicial District, my responsibilities include issuing direction to Clerks regarding their duties in instances where the law is unclear since, by law, clerks cannot issue legal opinions or make legal determinations. Until the U.S. Supreme Court issued its decision in *Obergefell v. Hodges*, No. 14-556 on June 26, 2015, the issue of whether same sex marriage licenses could be issued in Kansas was a legal issue requiring a legal determination. Accordingly, the Clerk referred the matter of the application of Thomas Tuozzo and Rodd Hedlund to me for my review and determination as to whether these same-sex applicants were "legally entitled" to the marriage license under the provisions of K.S.A. 23-2505(a) (2014 Supp.). I issued Administrative Order 14-13 on or about October 8, 2014. This order reflects my determination as a judge concerning whether applicants Tuozzo or Hedlund or any other same-sex applicant, could receive a marriage license in Kansas at that time. I directed the Clerk's Office to act in accordance with Administrative Order 14-3. This decision was made by me as Chief Judge of this District and was not made by Douglas Hamilton or his deputies. I rescinded Administrative Order 14-13 when I issued Administrative Order 14-17, which "instructs the Clerk of the District Court to issue marriage licenses to all qualified applicants without regard to the gender of each applicant."

On June 26, 2015, the United States Supreme Court issued its decision in *Obergefell v. Hodges*, No. 14-556, 135 S. Ct. 2584 (2015). My legal opinion is that *Obergefell* requires all states to issue same sex marriage licenses to otherwise qualified applicants. By its terms, the decision in *Obergefell* is not limited to Ohio, Michigan and Kentucky. Given the Court's holding in *Obergefell*, the statutory and constitutional prohibitions in Kansas law governing the issuance of same-sex marriage licenses are unenforceable as of the date of the *Obergefell* opinion. Because this District has been issuing same sex marriage licenses to any otherwise qualified applicant in accordance with my previous Administrative Order 14-17, I believed that the decision *Obergefell* did not require me to issue another Administrative Order on the subject.

I am issuing this Administrative Order to eliminate any possible confusion about whether the Clerk of the District Court for the Seventh Judicial District is issuing, and will issue in the future, marriage licenses in compliance with *Obergefell* and my Administrative Orders. *Obergefell* controls this district's policy as of June 26, 2015. The Clerk of the District Court and his deputies have been issuing marriage licenses to same-sex couples and are hereby directed to continue to do so in the future on the same terms and conditions as those applicable to opposite sex couples. This Administrative Order shall remain effective without regard to whether a permanent injunction is entered in *Marie v. Mosier*, 14-cv-02518-DDC/T JJ (D. Kan) or whether any preliminary injunction remains in place.

RULE NO. 26 ELECTRONIC FILING REQUIREMENTS

- A. *Electronic filing Mandatory.* All licensed attorneys must submit all new cases and documents to be filed within existing cases for filing with the District Court of Douglas County, Kansas, utilizing the Kansas Courts Electronic Filing system. Attorneys utilizing the system should acquaint themselves with and follow Kansas Supreme Court Order No. 268. Except as modified herein all local rules presently in effect continue to apply to all cases and documents filed through the e-filing system.
- B. *Chambers Copies.* When a-filing any motion, reply to a motion and /or briefs in support of such motions, counsel shall deliver a printed chamber copy of the documents to the administrative assistant for the assigned judge. If the individual judge agrees to receive chamber copies in electronic format counsel may submit them to that judge electronically.
- C. *Transcript Orders.* Counsel should notify the court reporter responsible for producing the transcript when an order for transcript is signed by the judge.
- D. *Indigent Defense Panel Vouchers.* Appointed counsel should deliver felony vouchers directly to the judge presiding over the case. Counsel should note-file the vouchers. Attorneys appointed in misdemeanor cases should e-file the face sheet of the voucher containing the total amount being claimed. The attorney should deliver any documents containing supporting itemizations of the time expended by the attorney to the presiding judge. Attorneys should deliver motions and orders requesting that the judge find that the case was exceptional: Attorneys should deliver such motions and orders directly to the judge. The court will return felony vouchers to the attorney once they are approved. The attorney should then submit the voucher to the Board of Indigent Defense Services.
- E. *Attachments to Motions and Briefs.* When possible persons filing pleadings with documents attached should file the attachments as part of the original documents to which they are attached. If the filer is unable to include the attachment with the original document because of size restrictions, the attorney should e-file the attachments separately and should label the attachments in E-flex in such a way that the label identifies the document to which it is appended.
- F. *Document Names.* When e-filing documents, attorneys should use names or descriptive terms that fully identify the document and the party filing the document.
- G. *Journal Entries in Criminal Cases.* Prior to filing a proposed journal entry for the judge's signature in a felony case, the District Attorney shall give a copy of the journal entry to the defense attorney, The District Attorney shall wait ten days from submission of the proposed journal entry to the defense attorney to file the proposed journal entry. This waiting period does not apply if the defense attorney approves the journal entry prior to the expiration of ten days.
- H. *Filing of the Original Wills in Probate.* When a party files a petition to admit a will to probate, the party should attach a copy of the will to the petition. The party should also file the original of the will with the clerk of the district court.




