



## **RV-970/Pop-Up-920/Camping Trailer-920 FORM-Complete one per vehicle**

Motor homes, campers, fifth wheels and travel trailers that meet the statutory definition of recreational vehicles are required to be titled as recreational vehicles. RV titled vehicles are classified under the “taxed when tagged” category. The personal property taxes are based on the age and “curb weight”, “shipping weight”, “dry weight”, “unladen weight” or “empty weight” of the recreational vehicle. **The GROSS WEIGHT IS NOT USED.** The age and weight-based tax value cannot be adjusted for condition or mileage of the vehicle. If the empty weight is not reflected on the MCO or title, and cannot be established, the vehicle must be weighed on a certified scale, and the taxpayer must provide a certified weight ticket showing the empty weight of the vehicle.
