#### **ADMINISTRATIVE ORDER NO. 18-12**

#### ORDER AMENDING ATTORNEY COMPENSATION IN NON-FELONY CASES

Each attorney appointed to a non-felony case filed after January 1, 2018 shall be compensated at the rate of \$80 per hour for time spent in preparation for trial or appeal, and for in-court representation, subject to the limits hereinafter established for reasonable compensation.

Reasonable compensation shall not exceed \$1,200 in any misdemeanor case that is not submitted to a judge or jury, and shall not exceed \$2,000 in a case submitted to a judge or jury, or \$2,500 if submitted to the appellate court.

Reasonable compensation shall not exceed \$500 for indirect contempt of court, care and treatment, modification of sentence, and probation, parole or assignment violation cases.

Compensation for attorney services in excess of the amount established as reasonable compensation will be paid only in those circumstances in which a motion for an exceptional case finding is submitted to and approved by the judge to whom the case is assigned.

An exceptional case is a case tried to the court or jury in which the attorney has expended fifteen (15) hours or more in court in defense of the indigent defendant, or the case is one of extraordinary complexity. Each claim for compensation for an exceptional case shall be accompanied by a motion setting forth the basis for the requested funding.

Appointed attorneys may be reimbursed for allowable expenses reasonably incurred in the performance of duties and approved by the appropriate judge. Allowable expenses include toll calls, exceptional postage costs, the cost of binding the required briefs for cases appealed to the appellate court, and travel expenses for appearances in the appellate court which shall be compensated at the rate set by the Board of County Commissioners for county employees. Other expenses may be considered on a case by case basis by the assigned judge.

Claims for compensation shall be submitted in the form established by the Local Court Rules, and shall be approved by the assigned judge. Payment of

approved claims shall be made from the general fund budget of Douglas County, Kansas, authorized for the District Court.

The Clerk of the District Court is directed to deliver a copy of this order to all attorneys practicing in Douglas County and the Douglas County Administrator.
