- EMPG Grant
  - o Submitted application packet last month to State. Awaiting results.
- COVID-19 -
  - Discussion surrounding vaccinations and the phases of administering. Phase 1 is divided into 1A and 1B. 1A is current main focus; anticipating vaccine release mid December. Everbridge will be used for mass communications for those in 1A. Round 1B will expand to other essential workers.
  - o KDHE has funding to conduct mass testing across the state. Currently scouting testing sites that can be used for continuous scheduled testing for 7 days at 8 hours per day.
  - O Public Health conducted mass testing in November in Lawrence, Eudora, Baldwin City and Lecompton. EM volunteers assisted. 1900 tests were administered. Reservations were required. Additional testing is being discussed.
  - o Surveillance testing has been conducted in schools. KU conducted exit testing on students.
  - O Non-Congregate Shelter Kansas was funded through FEMA to establish housing services through a local hotel for individuals needing to isolate or quarantine. This is at no cost. There are currently 12 people in Lawrence's non-congregate shelter. Read more about this program: http://www.dcf.ks.gov/Newsroom/Pages/NonCongregateHousingUpdate.aspx
  - o KLC Kansas Leadership Center working on campaign to "Beat the Virus". Their goal is 1000 meetings by the end of the year with other agencies; discussing challenges surrounding COVID-19.
  - Unified Command -
    - Well-being branch will receive CARES Act funding. Working on campaign for community.
- VOLUNTEER Update
  - o EM Volunteers assisted with surveillance testing in Lawrence, Eudora, Baldwin City and Lecompton.
- OUTREACH AND SUPPORT
  - o First Town Hall meeting in November received great feedback. Another Town Hall meeting is in discussions.
