- Recovery Support Functions phase of COVID-19. Framework graph discussed.
- Recovery Team met for first meeting last Friday and will meet every other week. Each RSF meeting on their own. EM will continue to coordinate the overall recovery effort with the recovery team.

- LEOP received extension from State with new due date of August 2021. Awaiting Kansas Planner's new template to be released. EM staff plans to complete LEOP by the end of this calendar year.
- EM Staff continuing to work remotely and meets weekly and as needed to discuss.
- Duty Officer training continues every week.
- Volunteer training when possible. Looking into volunteer opportunities to hold virtually.
- May 28 tornado anniversary EM, SO, PIO, City of Lawrence and Bert Nash prepared 7 days of social media coverage pertaining to videos, mental health, debris management and long-term recovery.
- COVID-19 for DGCO is at 67 with 64 recovered.
- COVID-19 for State of Kansas has reached 10,000.
