 Campground was approved and will be used for higher risk community. Longterm goal to utilize campground to free space in shelter.
 - Hubert White, Haskell Continued COVID testing via drive thru. Administering flu vaccine via drive thru. Currently Code Green and Incident Command Team has been structured. Plan to convert storage facilities into medical facilities to house infected. University campus is temporarily closed. The Billy Mills Cross Country Course and the West Perimeter and East Perimeter Roads are open for only walking. All other areas closed until further notice. No vehicle access allowed.
 - Jasmin Moore, Equity Advisor Helping to elevate equity within group and leverage work within planning process. Focusing on how COVID-19 is affecting different populations and elevating work within sustainability office for Douglas County and Lawrence.
 - Teya Grigler, Heartland Community Health Center Conducting drive thru COVID-19 testing. Will begin flue clinic end of October.
 - Teri Smith, LMH Completed tabletop exercise in September as requested by Infectious Disease Dr's to evaluate surge response. After Action Report conducted soon.
 - o Sonia Jordan, LDCPH Flu and COVID-19 clinics are ongoing.
