#### Minutes – Kay Johnson

Entertained a motion to receive the virtual meeting minutes for December 2, 2020. Mike Russell made the motion to accept and was second by Mike Baxter. All members voted in favor to approve.

Staff Updates – Robert Bieniecki, Jillian Rodrigue and Josh Taylor

- Plans
  - EOP State extended deadline to December 1, 2021. Beginning process for new template and update ESF information that was received. Then will distribute to partners for second look.
  - IPPW only received 10 responses to survey; will be sending follow up to obtain additional responses. Will use this as preparedness priorities for workshop at April board meeting.
- HMEP Grant
  - RFP has been awarded to Tetra Tech. Will not have to submit to County Commission for approval as total below \$50,000 threshold. Osage and Jefferson Counties will participate and divide payment based on county population.
  - $\circ$  HMEP 2022 due on the 8<sup>th</sup>, internal goal to submit by end of the week.
- EMPG Grant
  - Status unchanged. Waiting for 2020 refund.
- FEMA Assistance for Firefighters Grant
  - EM staff assisting Douglas County Consolidated Fire District #1's Chief Baxter with application process. Grant from Federal Government and is designed to assist Fire entities with accomplishing mission objectives by providing funding for PPE, vehicles/apparatus, employment and recruitment retention. Very competitive grant.

- Mass vaccinations began last Friday over 1000 vaccines given at that time. Today's event will administer over 1000 vaccines. Conducted as drive thru process at fairgrounds. IAP is created for each event and is structured similarly to any event involving Command System.
- Public health has vaccination plan based on "buckets" of people in phases. Possible change of process for school district employees due to concern about substitutes for teachers during class time. Looking into scheduling clinics on weekend/evenings to help.

- United Way recruiting volunteers to help with mass COVID-19 vaccinations clinics in Douglas County. When volunteers are needed, a request for help will be sent to those who have signed up. Volunteers are not guaranteed vaccine earlier than anticipated.

- Mass Testing continues at south Walmart. Available to Douglas County residents from 7:30am – 5:30pm Monday through Saturday starting Feb 2. Saliva based test. Does not require insurance or identification. Register per vehicle. Information and registration: <u>Gogettested.com/Kansas</u>
- Non-Congregate Shelter Kansas was funded through FEMA to establish housing services through a local hotel for individuals needing to isolate or quarantine.
